(NOTE: Banner week runs from Sunday to Sunday)

*Banners must meet the specifications set forth in the "Policy for Use of Banners Over Main Street" adopted by the Brattleboro Board of Selectmen on 12/13/77, (most recently amended 07/01/16), which is attached for your information.

*All banners shall be made of heavy-duty **mesh** to withstand the wind and weather.

*Banners must be delivered to the Central Fire Station **seven (7) days in advance** of the requested hanging date.

***Banners must be picked up within one week after the banner is taken down.**

*Banners are hung by the Brattleboro Fire Department and will be hung only if the Department's equipment is available.

*No guarantees are implied by the permit process.

***A hanging fee of \$150.00 is required *prior* to the issuance of permit for local organizations.**

***A hanging fee of \$300.00 is required *prior* to the issuance of permit for organizations located outside of Brattleboro.**

Above fees are per week duration of hanging.

Indemnification Agreement

AGREEMENT, made this ____ day of _____, by and between _____ (hereinafter called "Indemnitor");

WHEREAS, the Indemnitor would like to hang a banner across Main Street, Brattleboro, Vermont, from the westerly face of a building located at 143 Main Street, to the easterly face of a building known as The Brooks House; and

WHEREAS, the Fire Department of the Indemnatee has the necessary equipment and manpower to hang said banner;
